Vienna Set for 23rd European Regional ITS Conference and 3rd ITS Ph.D. Seminar

ITS2012Vienna

The last time ITS held its European Regional Conference in Vienna the Eurozone was still three years from its inception, James Cameron's movie "Titanic" had not yet been released, Steffi Graf was still the top female tennis player in the world, the Presidents of Russia and America were Boris Yeltsin and Bill Clinton, respectively, and the summer Olympic Games had just wrapped-up in Atlanta, Georgia. That was in 1996.

Now, sixteen years later, ITS returns to Vienna to convene the 23rd European ITS Regional Conference, July 1-4 and the 3rd ITS Ph.D. Seminar, July 4-5. The theme of ITS2012 Vienna is *Technology Drivers and Market Changes*. It is being hosted (together with the Ph.D. Seminar) by the Vienna University of Economics and Business, RTR – The Austrian Regulatory Authority for Broadcasting and Telecommunications, and SBR Juconomy Consulting (Vienna).

The principal ITS organizers for ITS2012Vienna are ITS Vice-Chair, Brigitte Preissl (ZBW - Leibniz Information Centre for Economics, Hamburg) and Jason Whalley (University of Strathclyde Business School, Glasgow). Local organizers include Wolfgang Briglauer and Klaus Gugler of the Vienna University of Economics and Business, Paul Pisjak (RTR), and ITS Board member, Ernst-Olav Ruhle (SBR Juconomy Consulting – Vienna). Both the Conference and Ph.D. Seminar will be held at the Vienna University of Economics and Business.

Looking out towards the remainder of the year, ITS has scheduled several more conferences to engage its members in scientific inquiry, discussion and lively debate. The 23rd European Regional ITS Conference will be held in Vienna, Austria, July 1-4. The theme of this Conference is *Technology* Drivers and Market Changes. It will be hosted by the Vienna University of Economics and Business, The Austrian Regulatory Authority for Broadcasting and Telecommunications (RTR), and SBR Juconomy Consulting (Vienna). The principal ITS organizers for the European Regional Conference are ITS Vice-Chair, Brigitte Preissl (ZBW - Leibniz Information Centre for Economics. Hamburg) and Iason Whalley (University of Strathclyde Business School, Glasgow). ITS will hold its 3rd Ph.D. Seminar for promising graduate students July 4-5, immediately following the Vienna Conference. As in prior years, papers addressing a broad range of ICT-related topics will be accepted from approximately 10 to 15 Ph.D. students. A panel of some 15 to 20 leading academics and industry professionals from the broader ITS community will be invited to review these papers and then, based on their many years of research and industry experience, provide their personal insights on the ideas presented together with suggestions on how they may be developed further. Vienna Set for 23rd European Regional ITS Conference and 3rd ITS Ph.D. Seminar (cont'd)

Major sub-themes to be addressed at the Conference include the following:

- Role of regulation in promoting superfast broadband and Europe's 2020 Agenda
- Super-broadband needed by a niche, while the mass market is served by mobile?
- The relationship between telecommunications and economic development
- 4G licensing and launching
- Spectrum allocation, re-farming and the use of the digital dividend
- Innovative business models for broadband delivery and mobile applications
- Technological, economic, regulatory and institutional convergence
- Media convergence
- The relationship between content, equipment producers and infrastructure industries
- Regulatory institutions resources, success factors etc.
- Experiences on the implementation of the new regulatory framework
- Tools and techniques to investigate regulatory and economic issues

Although the Conference program has not yet been finalized, it is anticipated that well over 100 papers will be presented on these and related topics.

The journal *Telecommunications Policy* will consider publishing selected Conference papers based on merit and

pursuant to a rigorous double blind, peer-review process.

Deadline for Submissions Nears for 2012 ITS Biennial Conference in Bangkok, Thailand

Authors wishing to present papers at the 19th ITS Biennial Conference will need to hurry if they have not yet submitted their abstracts for consideration by the Conference Program Committee. The deadline for abstract submissions is May 30, 2012.



The theme of the 2012 Biennial Conference which will be held in Bangkok, Thailand, November 18-21, is "Moving Forward with Future Technologies: Opening a Platform for All". The Conference host is the Office of the National Broadcasting and Telecommunications Commission (NBTC) of Thailand.

The Conference Call for Papers invites submissions "from every segment of the telecommunications and broader ICT industries, from every corner of the globe, from all perspectives, and from as many professions and as many authors as possible – be they engaged in international research, policy-making, industry, government, consulting, non-profit endeavours or academic pursuits, including established scholars or students just starting their careers. The principal criterion governing the selection of papers for this Conference is research quality."

Suggested areas of research include, but are not limited to, the following sub-themes:

- Open Platforms and New Services
- Competition and Regulation in Transition Economies

- Innovative Solutions for the Business Sector
- ICT, Culture and Social Rights
- ICT and Economic Development
- Spectrum Policies and Frequency Allocation
- Convergences Between Telecommunications and Broadcasting
- Access Policies for Broadband Networks
- New Frontiers in Intellectual Property
- Digital Inclusion, Sustainability and Open Networks

Other proposals for Conference sessions will also be considered.

The Conference venue is the Plaza Athénée Bangkok, a Royal Méridien 5 Star Luxury Hotel located on Wireless Road, a beautiful tree-lined boulevard in the heart of the city's cultural, commercial and entertainment district. The hotel is exceptionally well-served by public transportation and offers quick access to major sightseeing and shopping destinations.

The Conference will begin with a Welcome Reception on Sunday evening, November 18, 2012. Conference proceedings begin the next day (Day 1) with a morning plenary session followed by two sets of parallel sessions in the afternoon. Four more parallel sessions follow on Day 2 of the Conference. Day 3 begins with two parallel sessions in the

morning followed by a closing plenary session in the afternoon. Lunch will be provided to Conference attendees on all three days. In addition, there will be a Welcome Dinner at the end of Day 1 and a Farewell Party at the end of Day 3.





Member Profile - Professor Hidenori Fuke



Long-time ITS Board member, Dr. Hidenori Fuke, is currently Professor of Info-Communications Industry at the Faculty of Global Media Studies, Komazawa University in Tokyo, Japan. The University, one of Japan's oldest, was founded by the Soto-shu sect, one of the two main Zen Buddhist traditions in that country. Professor Fuke recently stepped down as Dean of the Faculty after being asked by the University to serve as the first Dean of the new Graduate School of Global Media which will open next year.

Dr. Fuke was elected to the ITS Board of Directors in 1998 and, since then, has contributed to the scholarly and scientific work of ITS both in his current capacity as a member of the Conference and Seminars Committee and, for a number of years, as Chair of that Committee. Over the past 14 years, Professor Fuke has assisted with the organization and program development of numerous ITS Conferences around the world. He especially active in the organization of the 18th Biennial and ITS Silver Anniversary Conference held in Tokyo in 2010.

Dr. Fuke has a strong background in telecommunications with a particular focus on regulatory policy. Earlier in his career, he served as a senior executive at Nippon Telegraph and Telephone (NTT) Corporation and has done extensive research on the info-communications industry and related regulatory policy as a member of the Board of Directors of InfoCom Research, Inc., a non-profit Corporate member of ITS. For a number of years, he also held the position of Professor of Network Industry, Faculty of Informatics, at Kansai University in Osaka.

Professor Fuke received his B.A. in Economics from Tokyo University, and his M.Litt. from Glasgow University in Scotland where he was sent for two years of post-graduate study by NTT. He received a Ph.D. in International Public Policy from Osaka University in 2004. His major areas of specialization include the economic analysis telecommunications industry and regulatory policy. In addition to being a frequent speaker and presenter on these subjects at international conferences, Dr. Fuke has published numerous books and articles in scholarly journals in both English and Japanese on his research interests. Professor Fuke's current research focuses on changes in the structure of the info-communications industry occasioned by the wide deployment of cellular and broadband internet, as well as the policy implications of these structural changes.

His special interest is directed at international roaming services on mobile networks. One of the difficulties he has encountered while undertaking research in this area, however, is that few countries, other than EU members, have established institutions for the collection of data and monitoring of these services. As such, Dr. Fuke welcomes any input, information or advice on this subject from ITS members with similar research interests.

When he is not engaged in research, writing or teaching, Professor Fuke

likes to travel abroad. He was particularly inspired by his trip last year to Dunhaung, an oasis city along the old Silk Road at the edge of the Gobi Desert that is famous for its Mogao Caves, and to Xi'an, one of the four great ancient capitals of China. He was impressed by the enterprising spirit of old China and the remarkable artistry and energy with which this civilization built ancient Terracotta Army. One of his favourite pastimes while at home in Japan is taking long drives in the countryside for the inspirational scenery and serenity they offer. He remains hopeful that the landscape of northern Japan and, more especially, the economic, physical and spiritual condition of the people living there, will some day be restored to what it once was following the devastation that was wrought by last year's earthquake, tsunami and nuclear disaster.

It is a hope and sentiment shared by his family, friends and fellow countrymen and, no less so, by all members of ITS.



The ZBW collects economics literature and subject-specific information from all over the world as well as books, journals and digital media from management practice. It then makes them available to users via interlibrary lending, document delivery and local lending. These materials form the basis of its sophisticated online information services. The ZBW is also a WTO depositary library and maintains a European Documentation Centre at its two locations in Kiel and Hamburg.

News from the ITS Board

Three New Directors Elected and One Departs
